Queenstown Trails Trust v Queenstown Lakes District Council (ENV-2019-CHC-026 (**Trails Trust Appeal**) being an appeal against decisions of Queenstown Lakes District Council on Stage 2 of the Queenstown Lakes Proposed District Plan (**PDP**).
