1 **Ian Rutherford and Jennifer Anne McPherson** wish to be a party to the appeal by Roger Lindsay Donaldson (**Appellant**) against a decision of the Queenstown Lakes District Council (**Respondent**) on its Proposed District Plan (**Proposed Plan**).

2 Ian Rutherford and Jennifer Anne McPherson did not make submissions about the subject matter of the proceedings.

3 Ian Rutherford and Jennifer Anne McPherson have an interest in the proceedings that is greater than the interest that the general public has, because they own property at 12 Mica Ridge, Millbrook, Arrowtown to which the zoning, objectives, policies, and rules under appeal relate. Their property would be directly affected by the relief sought by the Appellant. Their property is adjacent to the Appellant's property.

4 Ian Rutherford and Jennifer Anne McPherson are not trade competitors for the purposes of section 308C or 308CA of the Resource Management Act 1991.

5 Ian Rutherford and Jennifer Anne McPherson are directly affected by an effect of the subject of the appeal that:

5.1 adversely affects the environment; and

5.2 does not relate to trade competition or the effects of trade competition.

6 Ian Rutherford and Jennifer Anne McPherson are interested in all of the proceedings.

7 Ian Rutherford and Jennifer Anne McPherson are interested in the following particular issues:

7.1 The Appellant's appeal of the zoning of the Appellant's property as Wakatipu Basin Rural Amenity Zoning.

7.2 The Appellant's appeal of the minimum lot size provisions within the Wakatipu Basin Lifestyle Precinct.

8 Ian Rutherford and Jennifer Anne McPherson oppose the relief sought because they would be affected by the relief sought by the Appellant. Rezoning and change to the minimum lot size would not maintain and enhance the rural landscape and amenity values. The relief sought by the Appellant would result in intensification that would impact their lifestyle and the quiet enjoyment of their property.

9 Ian Rutherford and Jennifer Anne McPherson agree to participate in mediation or other alternative dispute resolution of the proceedings.
